- My name is Aaron Leung. I'm the Past Chair of the City of Vancouver Children, Youth and Families Advisory Committee
- 21 person advisory committee with a mandate to advise City Council, School Board and Park Board on matters related to children, youth and families
- Members as young as 7. 2/3rds of the Advisory Committee is under the age of 22.
- Currently stands discharged since November 2018. Council is voting on re-establishing Advisory Committees this week
- In 2016, the Committee took a position on the previous Long Range Facilities Plan and met with multiple Vancouver MLAs to discuss our concerns with the Ministry imposed 95% utilization ratio and budget cuts
 - A copy of the letter and motion are attached to this document
- In addition, the Committee took a position on school closures and the sale of school board land
 - A copy of the motion is attached to this document
- The Committee also took a position on the 2016 Milburn Forensic Audit. Specifically, I want to highlight our concerns with the recommendations regarding the sale of public assets
 - A copy of the motion is attached to this document.
- All motions received unanimous committee support
- At the time, the Committee was concerned with the potential sale of Kingsgate Mall to fund the Operating Budget and the impact of the sale of public assets on future generations
- The Committee motion related to the sale of public land states that "The Children, Youth and Families Advisory Committee strongly supports preserving public lands owned by the Vancouver School Board for future generations to fulfill its educational mandate for all present and future children"
- Today, I'm here as an individual to express my concerns regarding the updated Long Range Facilities Plan
- Specifically, I'd like to speak to the following:
 - The Lack of Public Consultation
 - o Concerns regarding capacity utilization projections and data quality
 - o Concerns regarding equity and community impacts
 - Addressing how the LRFP impacts and potentially conflicts with the Environmental Sustainability Plan

- I've participated in dozens of public consultations, facilitated some, and worked with multiple staff departments at the City of Vancouver to provide input on city projects and plans which totals 100+ hours
- Never. And I mean never have I been told that there is no plan or need for public consultation on a major plan
- As staff and Board Members can see tonight, the public is heavily investing in our neighbourhood schools
- Two Committee Meetings and an email account is not enough for an average plan and is certainly not enough for a wide-reaching plan that will impact the lives of hundreds of students if consolidation plans move forward.
- In 2018, I sat in this very seat and gave a presentation as an individual on the 2018/19 Operating Budget
- There were concerns at the time from members of the public that there was a lack of public consultation.
- I suggested that the Board adopt a Public Engagement framework based on International Association of Public Participation standards that allows for multiple opportunities of public comment, and breaks down the barriers to public participation.
- Once again, I'm reiterating my call to elected officials at this table to get a framework in place and also to slow down the LRFP update process to allow for public consultations in the communities who may be impacted by this plan, collect feedback, and adapt the plan as necessary to address community concerns
- No consultation plan is perfect. People will complain that there hasn't been enough public consultation. But having no consultation plan is unacceptable.
- Bluntly, if the Board plans to adopt this plan in April without doing so and informing school communities after the fact is unacceptable outcome.
- The public deserves broad consultation on the future of our public schools and public assets.
- In 2016, during the initial LRFP formulation, I had concerns about the utilization projection numbers contained in the report because they excluded non-enrolling space from the calculation. Effectively, I was told these spaces were marked as "empty" space
- In April 2016, the Manager of Facilities and a consultant came to my Committee at the time and I asked a question about getting a ball park on our current utilization excluding non-enrolling space
- I was told that because the LRFP was a Ministry commissioned report that staff did not have a number (or a ball park) and that staff were counting spaces as outlined by the Ministry
- Today, I and others are once again concerned with the utilization projects
- I'm calling on VSB elected officials to direct staff to include a utilization projection that excludes non-enrolling space as an appendix to this report so that we can get a clear idea and have a discussion about the future of so called "empty" space
- We know that non-enrolling spaces, like music rooms, libraries, and resource rooms provide a crucial support for our students. I and many others think that these spaces are well used and including them as "empty space" in the enrolment projections inaccurately depicts our schools

- Other members of the public have also noticed discrepancies in the FCI values and the operating capacity for certain schools listed in the LRFP appendices
 - Specifically, one parent noted that in the Cavell PDR, the FCI was listed as 0.60. In the LRFP it's now listed at 0.53
 - Some others have also listed concerns with current school population numbers.
 - For example, some have noted that for AR Lord, that there are currently 184 students (also confirmed by Ministry of Education data) at the school while the LRFP lists their population at 159
- In order to have a fair conversation, the public needs to have faith in the numbers that justify school consolidations, and I don't believe that the public has faith in the LRFP data due to how non-enrolling spaces are counted and the discrepancies found in the appendices
- The public has a right to open, and transparent access to data used in this plan.
- Tonight, I'm calling on VSB elected officials to direct staff to make all of the data from Baragar used to make projections and justify consolidation in the LRFP open access for public researchers through an open data database or as an appendix to the LRFP
- As an academic studying geography and spatial data at SFU, who first developed a passion for Geography in Geography 12 at Killarney, I've learned that methods in academic reports need to be reproduceable by researchers and open to scrutiny
- As the VSB is a public, academic institution, the public should be able to get transparent access to data (keeping in mind privacy concerns). As the VSB is a public, academic institution and if you are willing to stand by your projections, you should be open to scrutiny by academics and members of the public
- I also have concerns with the potential impacts to the Environmental Sustainability Plan
- The ESP states that the VSB wants to support active transportation to and from schools including walking and biking
- Consolidating neighbourhood schools will impact walkability and the VSB's active transportation goals if schools are farther away for students and parents
- In conclusion, staff and Board Members need to consider these tradeoffs when considering consolidation (equity, active transportation, socio-economic factors) not just capacity numbers

RE: Vancouver School Board 2016 Budget Deficit

We are writing to you today regarding the 2016 Vancouver School Board budget deficit of \$24 million. At our meeting on April 14th, the Children, Youth and Families Advisory Committee unanimously passed a motion to write to our local representatives and share our concerns about the state of public education in Vancouver. The Committee believes that every child must have access to a well-funded education system that supports their needs. Committee Members have noticed that over the past decade, education in B.C has been subject to continuous cuts to services that support students in their success. This year's budget deficit in Vancouver exemplifies the difficulties this district faces in delivering quality education to students.

Particularly, the Committee is concerned about the well-being of students attending public schools in Vancouver. Compared with the rest of the country, B.C has the second lowest funding per student and teachers are among the lowest paid in Canada. The process of seismically upgrading schools has already been pushed back from 2020 to 2030 in turn endangering the lives of students in at risk schools in the event of an earthquake. In 2015, the Committee wrote to the Select Standing Committee on Finance and Government Services about public education. The recommendations of the Standing Committee included "sustainable and adequate funding" for school districts (see attachments). Currently, the Committee sees the current service level and budget deficit as a failure of the Government to follow through on its own recommendations from a bipartisan committee.

With respect to the new government requirement of achieving a 95% utilization ratio in order to receive further funding for projects, the Committee does not agree that this is the best path for the support of a community learning environment. The Committee stands firm on its belief that critical childcare space and resource rooms should not be counted as empty space as they serve students in support of their educational goals. As the Vancouver school district looks at closing schools to meet this requirement, we see this both as a loss of vital community spaces and service accessibility for disabled and special needs children. Students deserve to stay in the schools that they call home and work in a space that is safe and seismically sound.



The lack of funding over the past decade is continuously putting British Columbia's strong education system at risk with many valued programs on the list of budget cuts. Once again, the Committee reaffirms its support for the arts and specialty education programs. We believe that every child in public schools should have access to programs that allows them to foster their potential and empower students to pursue their interests. Committee Members attended one of the budget consultations, and heard from citizens in the LGBTQ community that the Anti-Racism and Anti-Homophobia Teacher Mentor position, which is eliminated from this year's budget, saves lives. This is just one example of the real-world impacts to the wellbeing of students. Every year this district attempts to save programs for the benefit of students. But this year's deficit of \$24 million will most likely require cuts to cherished programs such as mini school and elementary school music programs. We ask that the B.C Government properly fund the education system, not only in Vancouver, but also throughout British Columbia so that students can continue to access imperative programs that meet their educational needs and ensures their safety.

If you are in Vancouver, Committee Members would appreciate a meeting with you in the coming weeks to discuss our concerns. We look forward to your reply and will be following up on our request.

- 2. The Children, Youth and Families Advisory Committee strongly supports preserving public lands owned by the Vancouver School Board for future generations to fulfill its educational mandate for all present and future children;
- 3. The Children, Youth and Families Advisory Committee acknowledges that in June, the Minister of Education allowed the Vancouver School Board to use a

portion of the money received from the sale of Kingsgate Mall to fund the Operating Budget if the Vancouver School Board were to sell the land;

4. The Children, Youth and Families Advisory Committee recognizes the Supreme Court of Canada's decision in favour of the British Columbia Teachers' Federation that recognizes the ability of the union to negotiate class size and composition as a part of their Collective Bargaining Agreement.

THEREFORE BE IT RESOLVED

A. THAT the Children, Youth and Families Advisory Committee oppose the disposal of any School Board owned property to balance the Operating Budget including, but not limited to school property and Kingsgate Mall;

FURTHER THAT the funds from the disposal of public property should not be used to fund the Operating Budget of the Vancouver School Board for it is the Province's duty to adequately fund public education and is not permitted through the *School Act*;

AND FURTHER THAT any consideration of the sale of public land be done by a Board of Education elected by Vancouver citizens and not by an appointed trustee from the Provincial Government.

- B. THAT the Children, Youth and Families Advisory Committee recommend that Vancouver City Council support this position to preserve public lands for the residents of Vancouver and future neighbourhoods, including the planned growth along the Cambie Corridor.
- C. THAT the Children, Youth and Families Advisory Committee acknowledge that the ruling from the Supreme Court of Canada may result in the need for more classroom space, therefore the process of property disposal should not be considered until the impact of this ruling is assessed and the completion of the negotiation process between the Province and the British Columbia Teachers' Federation on class size and composition is complete.
- D. THAT the Children, Youth and Families Advisory Committee send a letter to Dianne Turner, Official Trustee of the Vancouver School Board, the Minister of Education and the Premier of BC, copied to Vancouver City Council, and all Vancouver MLAs, outlining our concerns;

AND FURTHER THAT the above-noted letter be posted to the Children, Youth and Families Advisory Committee's Facebook page.
